Provisions

1. All Fees are minimum. All times are consecutive.
2. Transportation charges are extra, charged at the greater of \$0.40 per kilometre (km), or 0.5 times the current market price per litre. Cartage :\$50
3. The Leader is co-responsible for the good standing of all musicians.
4. For your protection, use and file an AFM Contract for Canada (LPCC) with the Local 293 office.
5. Leaders shall file a contract with the Secretary-Treasurer of the Local in which the engagement is performed at least 24 hours prior to the engagement.
6. On out-of-Local single engagements, book at the higher scale.
7. Licensed Booking Agent fees may not exceed 20% on single engagements; 15% for two (2) or more engagements on consecutive days. All booking agent fees must be over and above minimum scale. Please refer to the current Booking Agent Agreement, available at the Local 293 office.
8. Musicians' Pension Fund of Canada (formerly AFM-EPW Pension Fund (Canada)) contributions are a minimum of 5% to a maximum 15% and applies to minimum fees. Use contract form LPCC (Live Performance Contract Canada). Pension is optional for all above categories.
9. Note: Tariff of Fees for New Years Eve are Double
